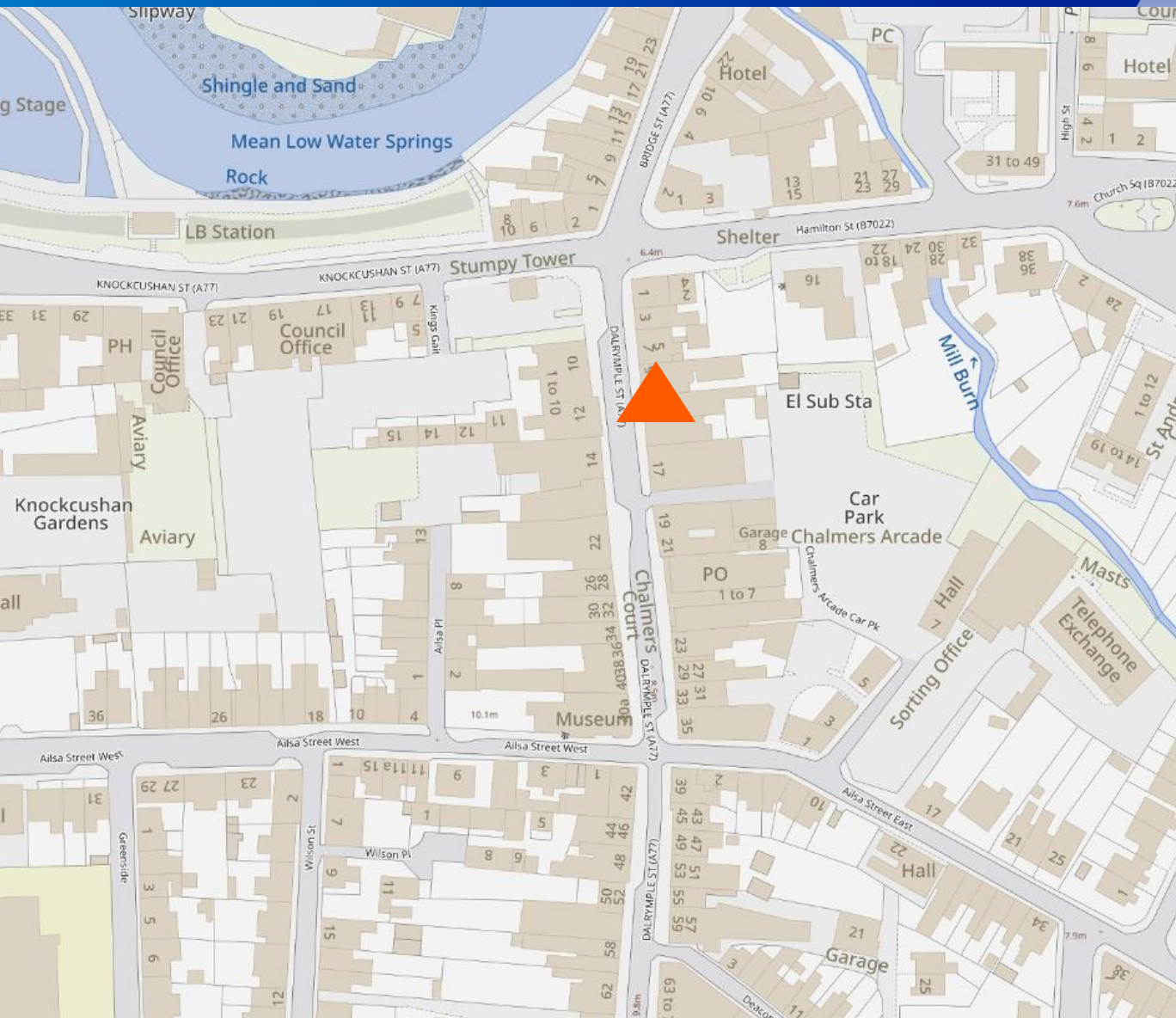






# Location
