I understand that I must make all reasonable endeavours to exchange and complete the sale of the Property within the next 40-business days. I understand that the role of the Auctioneer is purely to monitor the progress of the sale, but the acting solicitors are in control of the speed of the transaction, and any delay in sale progression after the auction will not entitle me to reclaim the Reservation Fee.
