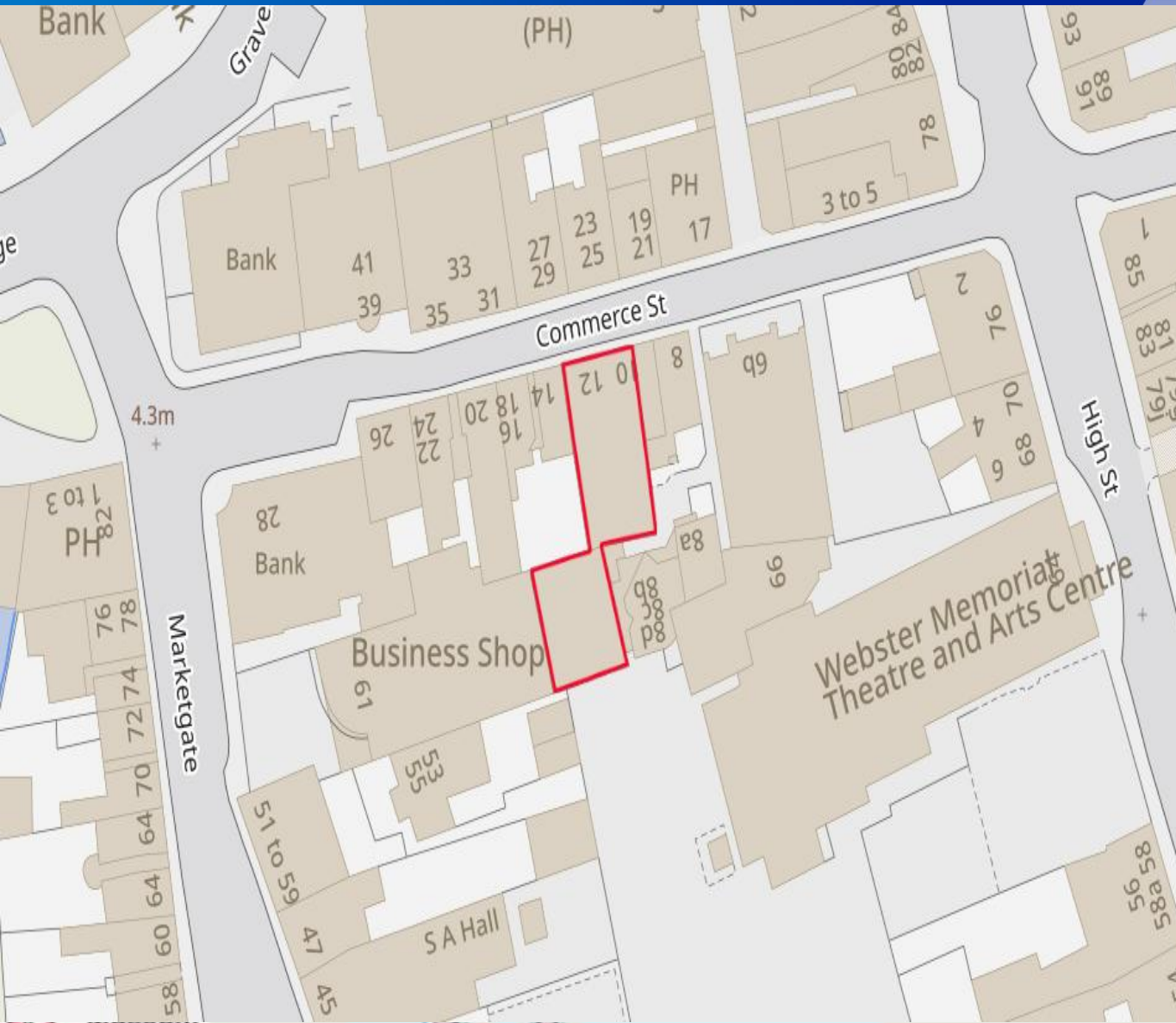

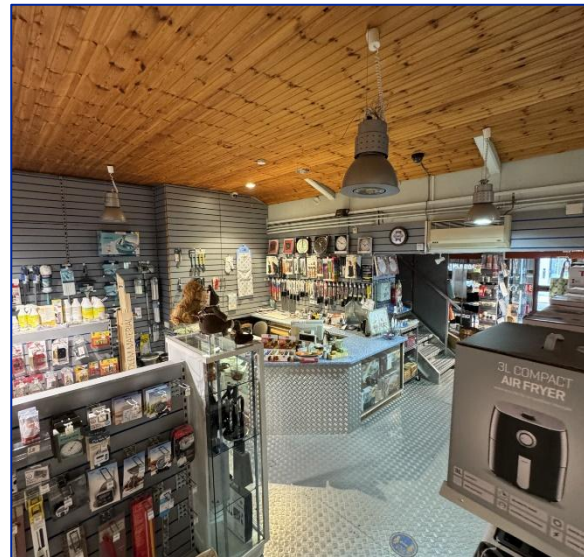
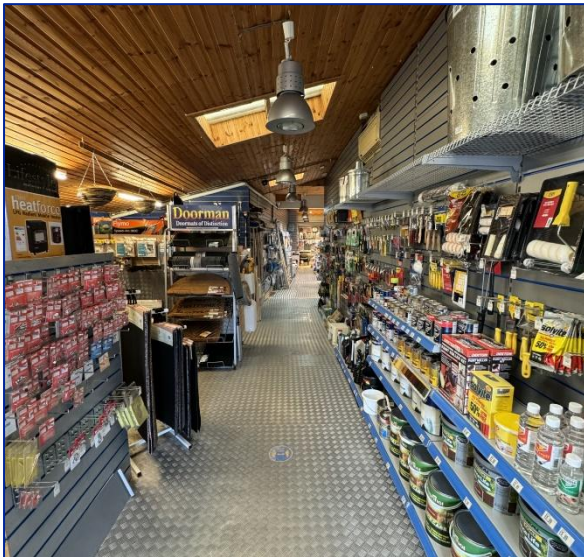

DESCRIPTION

The subjects comprise a mid-terraced two storey and attic retail unit fronting Commerce Street with single storey rear extension and storage area.

The retail unit currently trades as a cookshop/hardware shop. Internally the shop is laid out with ground floor retail space and office, staff room and storage on the first floor.

The property benefits from double window frontage onto Commerce Street. There is rear door access to the shop with a public car park located to the rear.



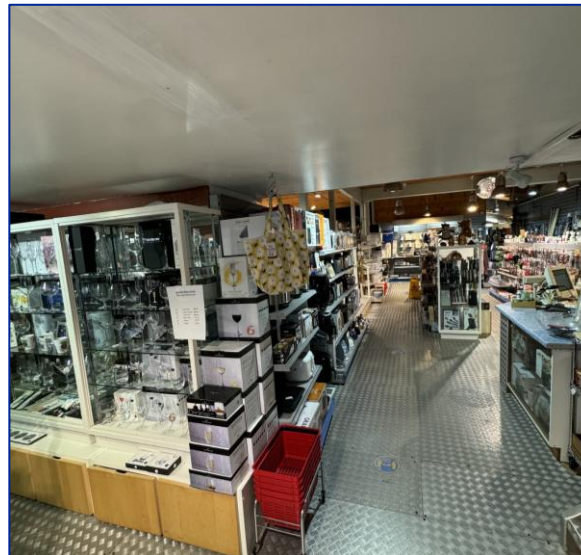
