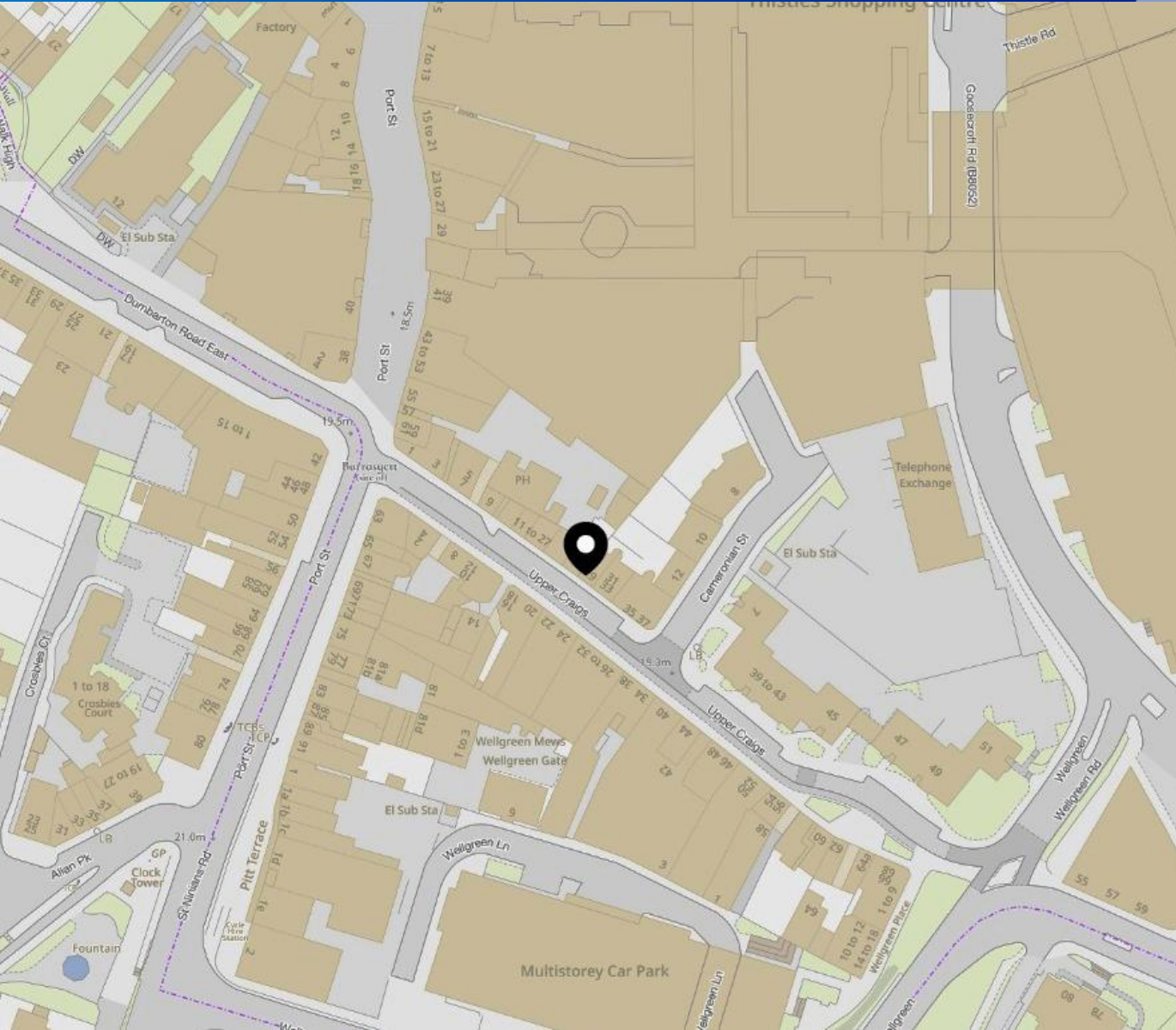

LOCATION
