The property is situated within the popular Abercrombie Court development of Arnhall Business Park, which lies approximately 6 miles to the west of Aberdeen City Centre in Westhill, a global hub for sub-sea engineering.

The property benefits from its close proximity to the A944, which leads directly to the Aberdeen Western Peripheral Route (AWPR) linking the north and south of Aberdeen.

Occupiers within the vicinity include Subsea 7, Yokogawa, Apex Tubulars, Miros Scotland Ltd and Axis Well Technology Ltd.

Description

The subjects comprise of a semi-detached two storey office building with external walls finished in brick with a profile metal sheet roof over. A small canopy projects out over the front entrance and is of steel frame design with a glazed roof over.

Internally, the ground floor is divided to provide an entrance vestibule, office accommodation, tea prep facilities and male and female W.C.'s. Within the office accommodation the flooring has been finished with carpet tiles with the walls being painted plasterboard and the ceiling being of a suspended acoustic design incorporating LG7 lighting. The W.C.'s have tiled floors and tiled walls to dado height with painted plasterboard above and are equipped with ceramic W.C. pans and wash-hand basins.

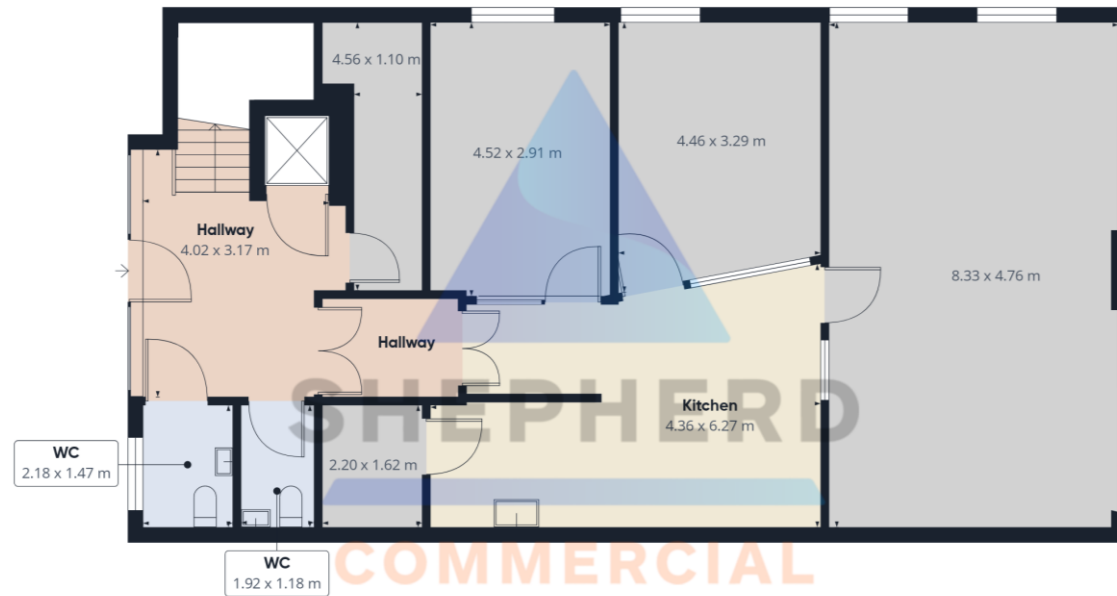
Access to the first floor is via a fixed stair or alternatively via a lift (DDA compliant) and is laid out to provide further office accommodation. The flooring is of a raised access design with a carpet finish with the walls and ceiling being of a similar finish as to the ground floor.

Externally, the subjects benefit from 10 exclusive parking spaces which include 1 disabled space.

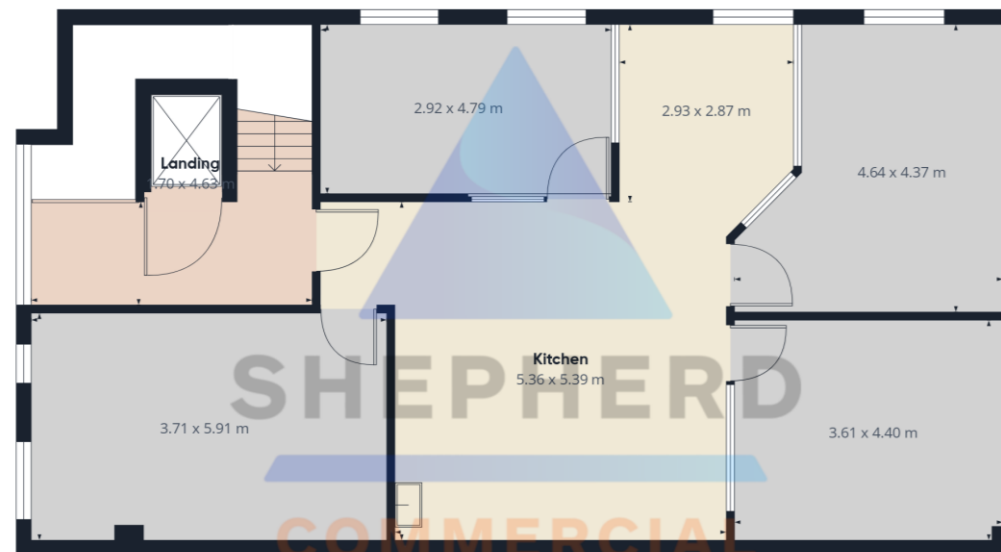


Floor Plans
