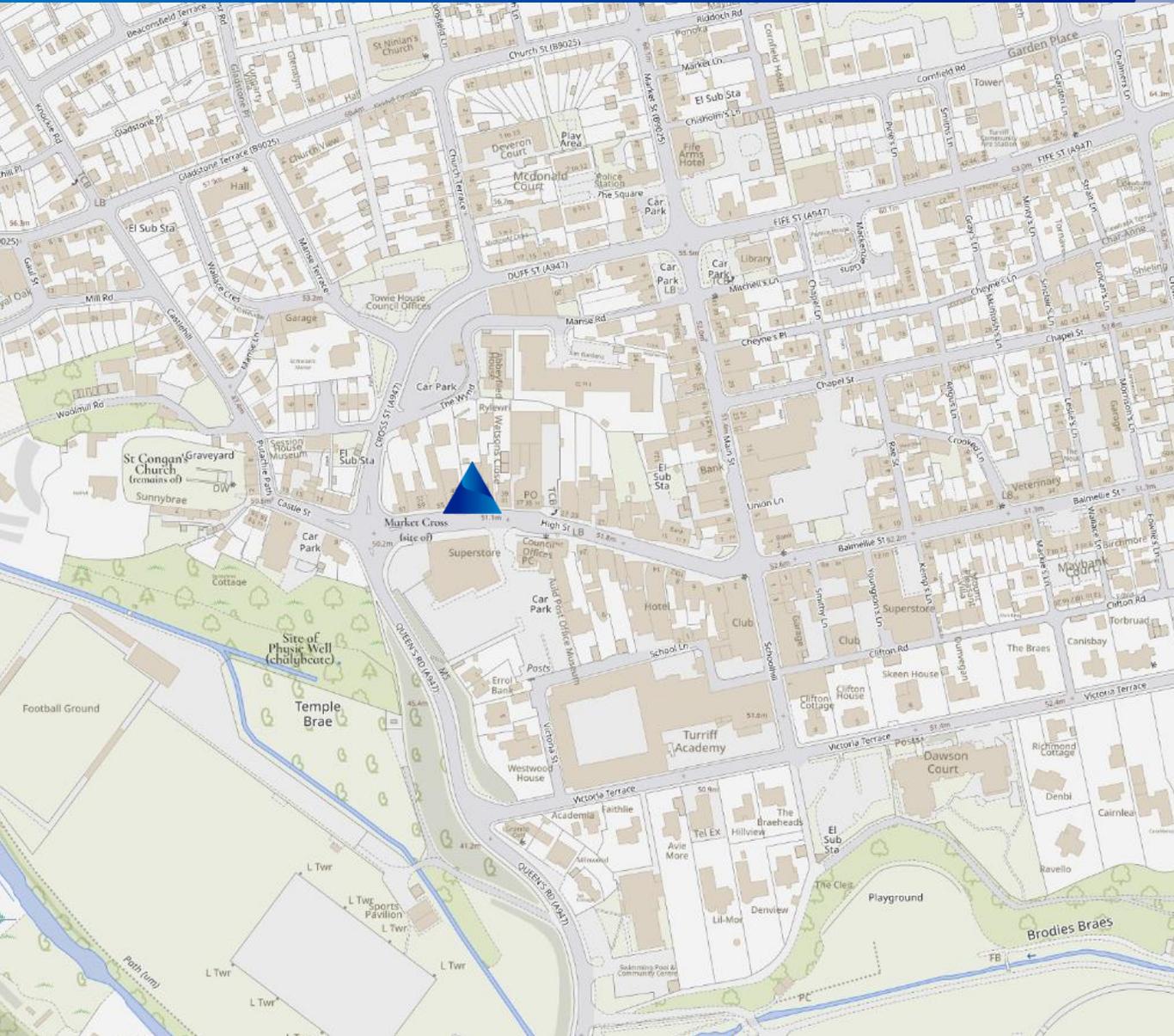

Location

45 HIGH STREET, TURRIFF, AB53 4EJ



The subjects are situated within the town of Turriff which is located approximately 35 miles northwest of Aberdeen. The town is well placed for commuting as one of the areas main service centres and offers a vibrant town centre.

The subjects themselves are situated on the north side of High Street, the main retailing area of the town. The subjects benefit from a reasonable level of passing footfall, with the surrounding properties mainly of retail use with the upper floors primarily residential. The premises occupy a prime position immediately opposite a Tesco Supermarket and the main car parking area for the town centre. Other nearby occupiers include Murdoch Allan, Costcutters, Stewart & Watson and Turriff Jewellers.

Description

The subjects comprise a ground floor retail unit forming part of a two-and-a-half storey, mid-terraced building of stone construction. Externally, the unit benefits from two framed glazed display windows together with a glazed pedestrian entrance door.

Internally, the accommodation is well laid out to provide a spacious front service and/or seating area, a kitchen preparation area, and a DDA-compliant W.C. Additional staff facilities and storage areas are located to the rear. The flooring across the premises is finished with a laminate style overlay, with walls being of painted plasterboard. Lighting is provided by a combination of spotlights and pendant light fittings.
