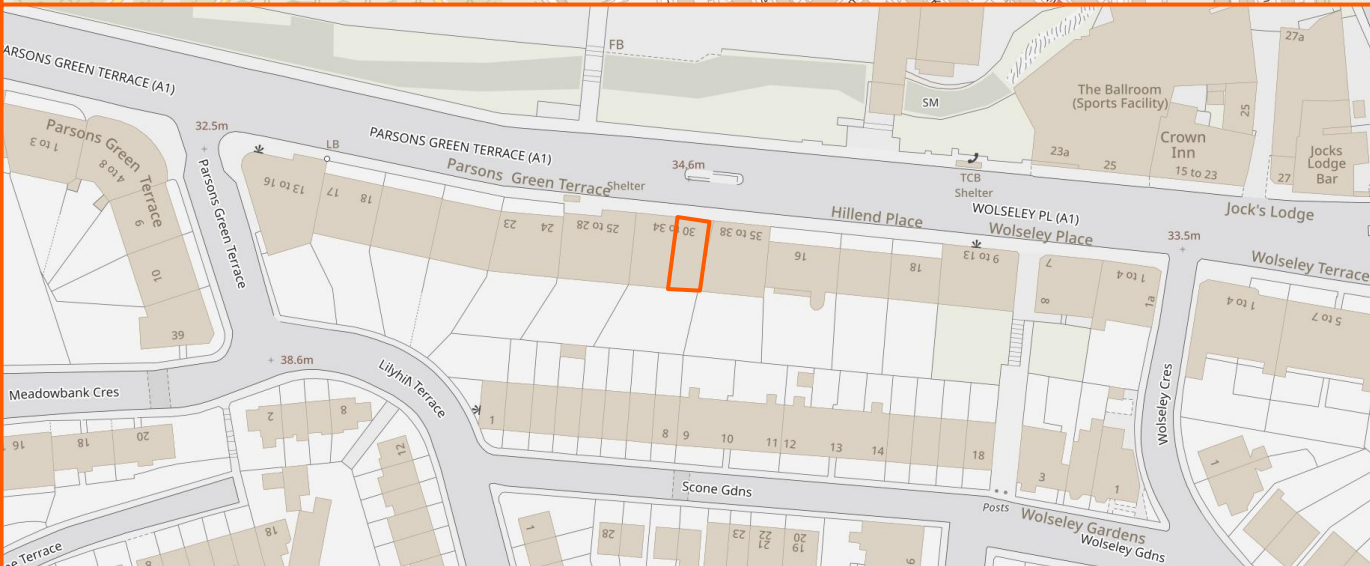
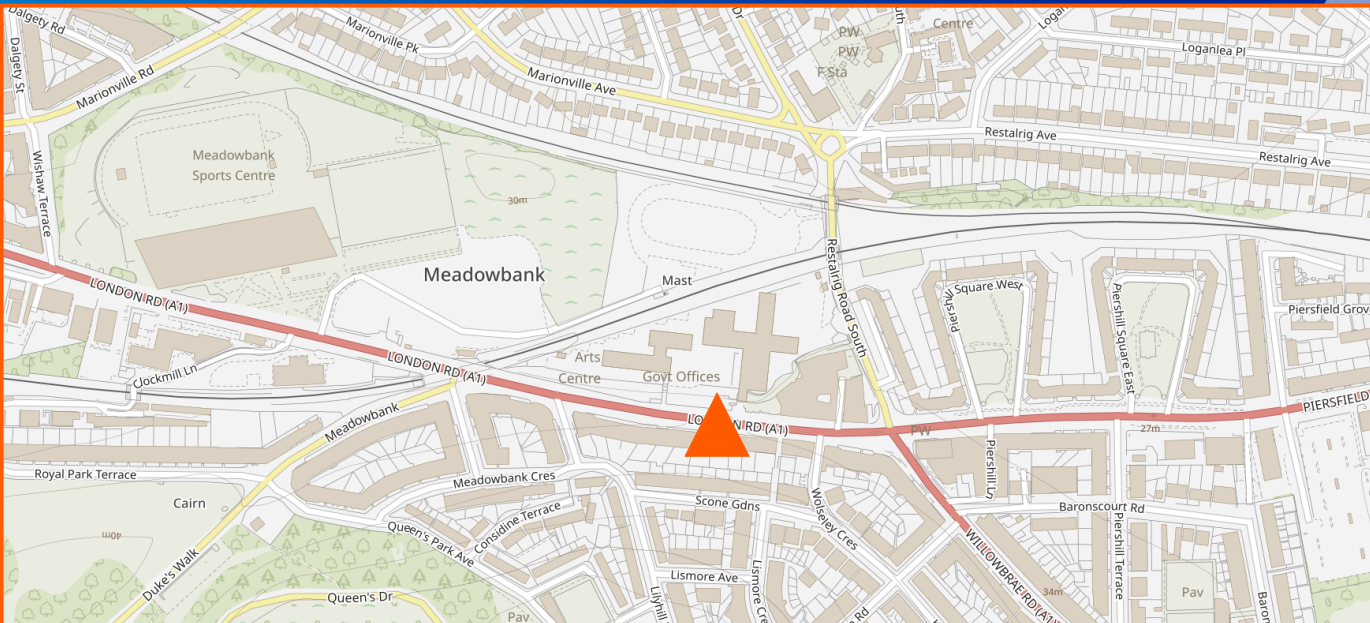

## Location

The premises are located in the Meadowbank district of Edinburgh, approximately 1 miles east of the city centre. Parsons Green Terrace forms part of the London Road which forms part of the A1 truck road. This is one of the main arterial routes linking the City Bypass and A1 to the east side of the city. The route also benefits from an extensive bus network not only for Edinburgh City but acts as the main link for East Lothian bus operators.

The subjects are located on the south side of Parsons Green Terrace, within the block bounded by Meadowbank Crescent to the west and Wolsley Crescent to the east. The nearby occupiers include Viva Hair Salon, The Embroidery Shop and Baba Rista.

The immediate surrounding area is about to undergo a dramatic transformation within the next couple of years that will see the development of 190 student flats. ## Description

The subject comprise a highly prominent Class 1A premises arranged over the ground floor of a four-storey traditional stone-built terrace with a single-storey projection under a flat felt roof. The property benefits from a double-glazed frontage which encourages significant exposure for vehicular passing traffic and pedestrians.

Internally, the space offers bright, open-plan accommodation, ideal for a variety of business uses, subject to obtaining necessary planning consent. Additionally, a W/C facility is located to the rear of the property.

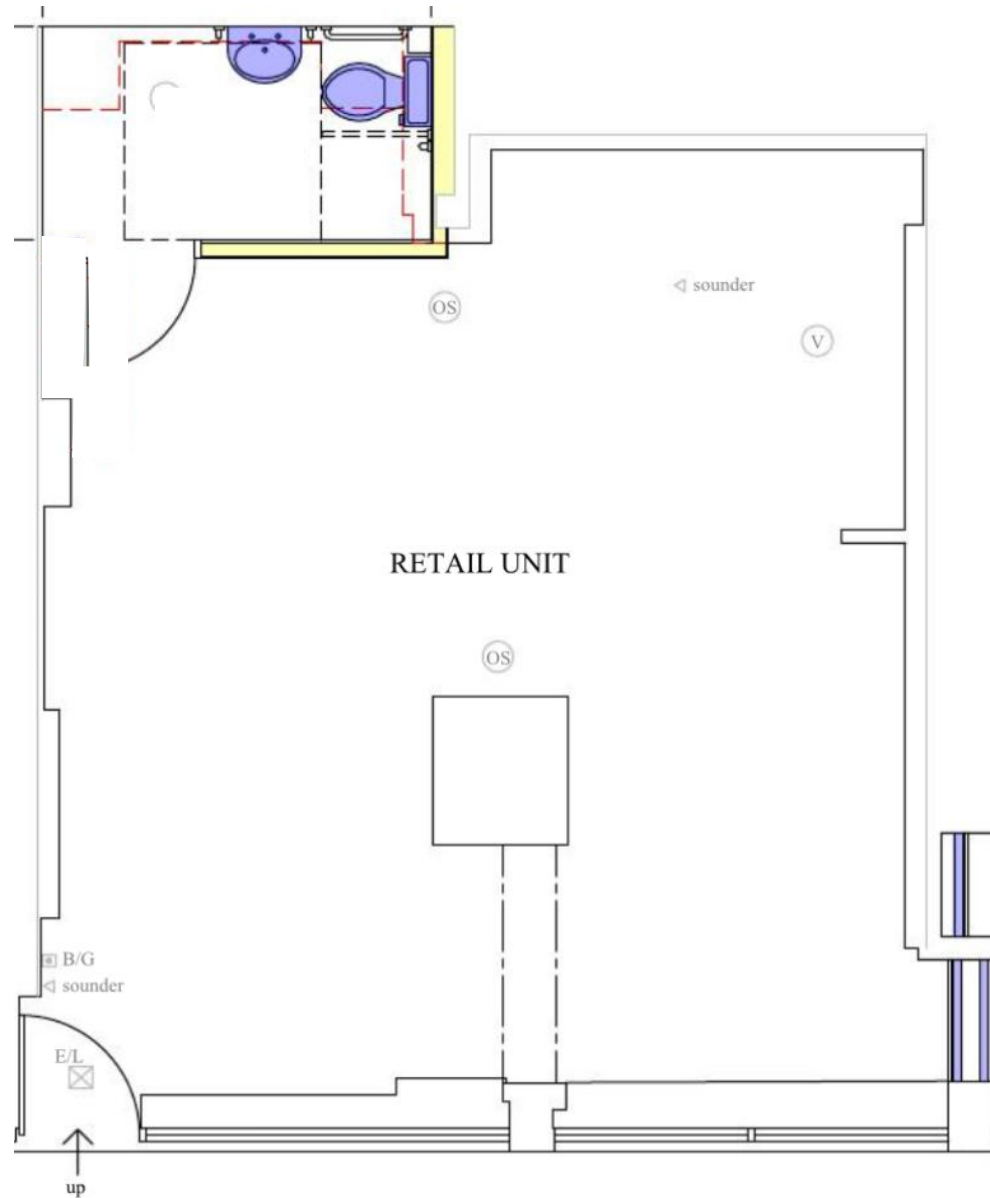
